

It consolidates everything from tracking public breach notifications to creating marketing campaigns—into a single, unified application.

Lawyers can easily manage client leads, create landing pages, generate QR codes, and even capture leads directly through custom-built forms. With a powerful AI conversation bot, CyberNet simplifies legal document management, ensuring the smooth execution of class action lawsuits.

The Problem

Keeping up with new data breach notifications was a constant challenge; manual tracking across multiple sources proved both tedious and inefficient.

At the same time, managing leads, documents, and campaigns relied heavily on manual processes or outsourcing, driving up costs and wasting valuable time.

On top of that, advertising campaign management was fragmented across multiple tools and platforms, making workflows unnecessarily complex. It was clear that a smarter, more integrated approach was needed.

- AI Legal Assistant: A built-in AI conversation bot helps lawyers quickly summarize and retrieve key points from large volumes of legal documents, enhancing efficiency and accuracy.
